Dear parents and carers,

As we enter the last week of term before the Easter holidays, I would like to congratulate all of our students on their positive attitudes towards school and the hard work they are putting in to their studies. We know that the last twelve months have been an extremely challenging time for our students and their families; it is great to see them back in school, attending school every day and working extremely hard.

# Lateral Flow Device testing

All students who have consented have now been given test kits to take home, so that they can start the home testing process. Students should take the LFD tests twice a week at home. We recommend that students do their tests on a Wednesday and a Sunday. Test results must be reported to NHS Test and Trace and also to the school, via the link that has been sent to you by Ms Brian. Any positive tests should be reported immediately by phone to the main office.

The government have asked that students and staff continue with LFD testing during the Easter holidays. This is to ensure that any asymptomatic cases that arise during this time are identified so that appropriate action can be taken. Please remind students to do their weekly tests during the holidays; this will help to reduce transmission of the virus.

# Masks and face-coverings

Please remind students that, in line with government guidance, they are required to wear masks in school, both in corridors and in classrooms. Laminated passes are available from the pastoral team for students who are exempt – students should speak to their tutor or Head of House about this. Students must not wear masks under their noses or under their chins, as this is unhygienic and can lead to the further spread of infection. Students must bring their own masks to school every day.

# Uniform and dress code

All students must wear correct uniform and dress code at all times. Trainers are not permitted and students must not come to school wearing jeans, hoodies, hats or caps. If there are any parents who need support with uniform, e.g. if a student has grown out of something during lockdown, please let us know so that we can help.

Students have been permitted to wear coats around the building and in classrooms during the cold winter months, owing to the need for windows to be kept open for ventilation purposes during the pandemic. After the Easter holidays, this will no longer be the case and students will once more be expected to remove coats as they enter the school building.

# **Challenge Partners seminar**
